- After the first three (3) months, the monthly On-Line Bill Pay fee is \$5.00/month (+tax) for unlimited transactions.
- Stop Payment - \$15.00; Copy of Cancelled Check - \$3.00; NSF Fee - \$15.00

Other information about On-Line Bill Pay:

- PLEASE SCHEDULE PAYMENTS TO BE PROCESSED, AT MINIMUM, 5 DAYS BEFORE THE PAYMENT IS DUE.
- Your account will be electronically charged on or about the 15th of each month for On-Line Bill Pay fees.
- You will receive a separate On-Line Bill Pay I.D. and PIN in the mail. You must use your On-Line Bill Pay I.D. and PIN each time you access On-Line Bill Pay functions.
- On-Line Bill Pay fees are in addition to existing Bank fees as listed in your deposit account agreement.
